

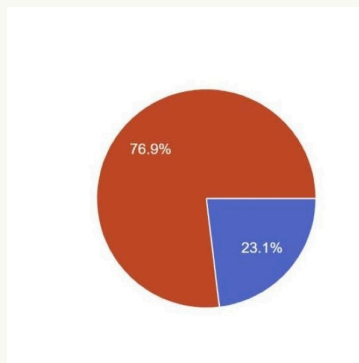
Survey results are in

And the results are clear – a majority of owners want to sell sooner rather than later.

Over the holiday period, we distributed a survey to determine owners' intentions regarding retaining or selling their timeshare week(s). The response was outstanding, **with more than 60% of timeshare owners (excluding Classic) participating**. This is well above typical survey response rates of 10–30% and provides a statistically robust dataset, delivering a better than 99% confidence level result with a margin of error of plus/minus 4%. That's an incredibly strong survey result.

In summary, almost 77% of respondents wanted to sell, with more than 51% wanting to sell within the next 3 years. 23% said no to selling.

Where to from here?

In the view of the Owners Support Group (OSG), these results provide clear and compelling evidence in support of the motion passed in 2025, which instructed the Body Corporate Committee (BCC) to work with owners and the OSG to produce a report on possible sale processes for owners wanting to sell while **respecting that over a third of the Unit Plan is privately owned and 25% of timeshare owners have no wish to sell**. Another 25% of the timeshare units are owned by Classic entities and we do not know their long term intentions. **This report is due before the 2026 AGM.**

To date, the BCC has not acted on this instruction. Accordingly, the **OSG is proceeding to advance this work** in order to ensure that owners' clearly expressed interests are properly addressed. **Further details** are provided later in this newsletter.

Rental options and considerations

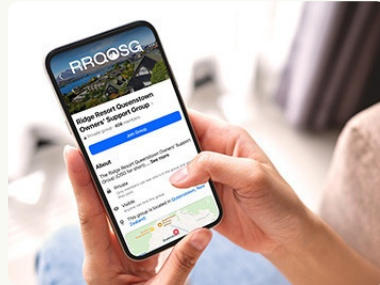
OSG has explored creating a platform to enable owners to rent out their weeks. **After careful consideration**, we have concluded that the risks currently outweigh the potential benefits.
